

OFFICIAL BARRIER TRIALS

PLEASE NOTE AMENDMENTS TO CONDITIONS FROM JANUARY 1, 2009

- Following an increase to the jockeys riding fee in official barrier trials, the fee to start in an official barrier trial has increased to \$60 (plus GST).
- The fee for horses that nominate, but do not start in official barrier trials will rise to \$80 (plus GST). This fee will be waived for any horse where a veterinarian certificate is received within two working days following the date of the official barrier trials.
- Trainers are required to advise the RISA Service Centre of scratchings in official barrier trials at least 30 minutes prior to the commencement time of the first official barrier trial. The connections of horses that fail to advise the RISA Service Centre will be charged an additional \$20 (plus GST).

BARRIER TRIAL PROGRAM

The following barrier trial program will be scheduled at each distance:

- Two-Year-Old • Maiden • Class 2 • Open

When sufficient nominations are received, 2YO barrier trials will be divided into Fillies and Colts & Geldings divisions. When insufficient nominations are received for any class, nominations will be combined with other classes until the field safety limit is reached.

DEAGON

Distances are 1200, 900 and 650 metres.

EAGLE FARM

Distances are 1100 and 800 metres.

DOOMBEN

Barrier trial distances:

No. 2 Grass A. (Max. 8 runners) approx. 1060m B. (Max. 8 runners) approx. 900m
No. 3 Grass A. (Max. 8 runners) approx. 960m B. (Max. 8 runners) approx. 860m

GOLD COAST TURF CLUB

Barrier trials are to be conducted on the B Grass and run over 1000m.

Under no circumstances will trials be postponed, however weather permitting, they may be transferred to the Velvet track on the same day.

SUNSHINE COAST TURF CLUB

Cushion Track Distances – 400m (approx) and 1000m

IPSWICH TURF CLUB

Barrier trial distance is 920m.

TOOWOOMBA TURF CLUB

Distances are 1050, 850 and 650 metres.

ROCKHAMPTON JOCKEY CLUB

Distances – Grass: 1000 and 500 metres
– Sand: 900 and 400 metres

Grass Trials – all horses to be shod with concave shoes or racing plates.

TOWNSVILLE TURF CLUB

Conducted on outside section of course proper over 850m.
